Mr. Johnston joined The Hundred Club in 1967 shortly after it was founded by Anthony Ustjanauskas. year the club had 31 J. Stewart Johnston dues-paying members.

Veteran Firefighter In Wolcott Succumbs

The first member of the Wolcott Volunteer Fire Dept. to lose his life in the line of duty, Deputy Chief Donald Maurice, succumbed after responding to a false alarm at Wolcott View Manor. He returned to

Donald Maurice the Co. 1 fire station and, after hanging his fire gear on the wall, collapsed. A massive heart attack took the life of Mr. Maurice April 8. He was 52 years old.

another, the office staff needed the assistance of a director.

Managing Director William E. Sydenham, Jr. said, "He was devoted to the club. Stew was always ready to help me. When it came to The Hundred Club the word 'No' was not in his vocabulary." Mr. Sydenham also noted that during meetings of the Board of Directors Mr. Johnston's opinions were highly respected by his fellow policymakers.

President Joel E. Janenda recalled that Mr. Johnston encouraged him to join the Club several years ago and urged him to be an active member. "Stew was one of a kind. He could not do enough for people and the organizations he believed in."

Mr. Janenda said that last spring after Mr. Johnston underwent surgery and was urged by family members to stay at home, Mr. Johnston attended a meeting of The Hundred Club's Board of Directors. "When I called and suggested that he not attend, Stew responded, 'Joel, you are not my doctor. And, I've already asked André Charbonneau to give me a ride."

According to Mr. Janenda, who lives and practices law in Manchester, Mr. Johnston was an energetic booster of community activities which he believed were in the best interest of his fellow townspeople.

After holding several offices in The Hundred Club, Mr. Johnston was asked in 1985 to serve as president in 1986.

Following his year in the presidency Mr. Johnston became a member of the Board of Directors and rarely missed a meeting. At the time of his death, Mr. Johnston was also serving on the Finance and Nominating committees.

A longtime resident of Manchester, Mr. Johnston moved to South Windsor with his wife a few years ago in order to be closer to other members of their family.

Mr. Johnston was born May 3, 1920 the son of James and Alice Dillon Johnston. He was educated in local schools and during World War II served with the U.S. Army in the Philippines. Following his discharge he returned to a position at Dillon Ford. In 1962 he became owner of the dealership and directed operations until he retired in 1988. During his active years in the automotive industry he was an officer and director in the New England Ford Dealers Association.

Mr. Johnston was predeceased by his wife of 61 years Ann Renn Johnston. He leaves two daughters, Mrs. Mary Lou Kupchunos and Peg Johnston of South Windsor, a son, Collins D. Johnston II of Manchester and seven grandchildren. He was predeceased by two brothers, Collins D. Johnston and Rev. Robert Johnston.

A Celebration of Life was held Nov. 22 in St. Mary's Episcopal Church, Manchester. Burial was in East Cemetery, Manchester.

a member of the department since 1972 and was widely known throughout Litchfield and New Haven counties as a dedicated firefighter. Members of the Wolcott department said that during his three decades of service Mr. Maurice responded to 90 percent of the calls. Also, he was credited with personally performing many of the time-consuming and less glamorous jobs including washing the trucks and the firehouse floors. In addition, he often cooked for his colleagues and was active in the department's fund-raising activities.

In 1982 Mr. Maurice was credited with rescuing two people during a raging fire. Officials at the scene said there was no doubt that Mr. Maurice, through his bravery, had saved the lives of the people he brought from the burning structure.

wife, Patricia, his mother, Lee, and several other relatives in the audience.

Mr. Janenda intends to stay active as a past president serving as a director.

An estimated 400 people, including firefighters from Litchfield, New Haven and Fairfield counties, filled St. Pius X Church for the Mass of Christian Burial. Fire Lt. Dennis Maurice, the brother of the deceased firefighter, delivered the eulogy. He said, "Saying goodbye to a friend is hard. Saying goodbye to a loved one is impossible. I'll never say goodbye to my brother."

Mr. Maurice's casket was carried on a fire truck from the Della Vecchia Funeral Home to the church. The Connecticut Firefighters Pipes and Drums led the procession. Following the Mass, the mourners marched to Woodtick Cemetery, where Mr. Maurice was buried.

Mr. Maurice was born in Southington Feb. 21, 1951, the son of Roger and Eleanor Maurice of Wolcott. In addition to his parents, he leaves his wife, Jean Palionis Maurice; a brother, Dennis Maurice and a sister, Dorina Maurice, all of Wolcott.
